

General Rules for Participation

The following is a list of instructions and forms that you must complete to register your team in this year's tournament. *All forms must be completed and received by 5:00 pm CST on Friday, November 19, 2021.* No late applications will be accepted.

1. **ELIGIBILITY AND VERIFICATION** – All participants must be verified as eligible to participate as listed in this section. Every participant must be legally listed on the dwelling lease of a low-income public housing property, multifamily property, Housing Choice Voucher Program, or a member of a Boys and Girls Club. The Housing Authority or Boys and Girls Club Executive Director is required to verify resident/membership status by signing the Certification form.

Age—The athlete's age determination date is the first day of the tournament, January 15, 2022. A copy of each athlete's birth certificate or Insurance/Medicaid card must be submitted with the team's entry application. Athletes without proper proof of age are ineligible.

AGE CLASSIFICATION:

18 & under Born after 1/15/2004 15 & under Born after 1/15/2007 12 & under Born after 1/15/2010

Education Activities/School Grades—Participants must abide by the following rules:

- Each athlete/student must be enrolled in school or in an approved GED program.
- Each participant is required to maintain an overall "C" average. If an overall "C" average is not maintained, participant is required to enroll in a tutorial program. The tutorial program may be administered by the school, local Housing Authority or other agency.
- Each team is responsible for having its team members involved in educational activities. Each team must submit a written summary of what it is doing to meet the above requirement. Failure to provide this information will make the team ineligible to participate.

High School Athletic Eligibility—Athletes listed on their school's basketball/cheer team during the current school year are prohibited from participating in this tournament.

- 2. **Code of Ethics/Conduct**—Participants are expected to display good sportsmanship at all times. The HUD Youth Sports Code of Ethics will be enforced. This form is to be signed by each athlete, coach, chaperone, and coordinator.
- 3. **Waiver and Release Liability Form**—Each athlete and coach are required to complete a Waiver Form for insurance purposes. Any athlete or coach without a completed and signed Waiver Form will be ineligible to participate.

- 4. **Educational Component**—Teams registered in the 30th Annual SERC Martin Luther King Jr. Basketball Tournament and Cheer Competition, are *required* to participate in the educational component of the weekend. This component is designed to not only provide entertainment for participating athletes, but also to educate them on the history, culture, and uniqueness of Tuskegee, Alabama. *Failure to attend the educational component will result in a team's forfeiture of their first game played*.
- 5. **Basketball/Cheer Team Roster**—Complete a roster for each team participating.
- 6. **Team Name**—Each team should have a unique team name. For example: The Wizards, The Eagles, Bobcats. Teams should avoid the following: OHA Blazers 18 & Under, OHA Blazers 15 & Under, etc.
- 7. **Entry Fee**—The entry fee is \$450 per basketball team and \$200 per cheer team. Make checks payable to the Opelika Housing Authority with SERC MLK in the memo line. Registration forms and checks may be mailed to P.O. Box 786, Opelika, AL 36803, Attn: Jessica Cook, Resident Services Director.
- 8. **Hotel Curfew**—Each team should establish a curfew time for athletes to be in bed. At the mandatory coaches meeting, the coaches will indicate the designated curfew time for their team(s).
- 9. **Chaperones**—Each team is required to have two (2) adults present at all times.
- 10. **Rules**—All age divisions may compete in an older age classification; however, older participants may not compete in a younger age classification. An athlete can only be listed on one roster. All age divisions will play 15-minute halves running the clock, and will stop only for time outs. Each team has two 30-second time-outs per half, and three full 60-second time-outs per game. Overtime will consist of five minutes running clock, each team has one full time-out. All teams will play with a 29.5" size ball. A mercy rule will be in effect. A running clock will begin once a team is ahead by 30 points or more. The clock will continuously run until the points difference is less than 20.
- 11. **Forfeits**—Any team that leaves the tournament early or misses a game may forfeit all of their remaining games, and may be fined \$100.00 per game missed.
- 12. **Awards**—All athletes will receive an official 2022 SERC MLK Basketball Tournament & Cheer Competition t-shirt. A team trophy will be awarded to the 1st, 2nd, and 3rd place winners in each age classification. Each athlete on the 1st place team will receive individual medals and all participating athletes will receive a commemorative gift.
- 13. **Uniforms**—Uniformity on the court will be enforced. Each team athlete must wear the same color shirts, shorts, and socks. Failure to do so will result in a technical foul for the first offense and forfeiture of the game for future offenses.

- 14. **Dress Code**—No visible jewelry, open-toe shoes or hats during play on athletes, coaches and/or chaperones. Coaches and chaperones must wear a team t-shirt or a collared shirt during play. Banquet attire will be a collared shirt and tie for males and dress or dress slacks for females. If one fails to comply, they will not be allowed to attend the banquet or play their first game. In the case of a coach or chaperone, the entire team will forfeit the next game.
- 15. **Photos**—Every team and executive director will be featured in the souvenir program book. Include a photo of your team(s) in uniform with a row-by-row list of names. Also, include a picture of your executive director. In order for your photos to be included in the souvenir book, they must be **received by 5:00 PM CST Friday, December 17, 2021.** Photo Tips: Make sure your team photo is taken in a well-lighted area with a bright background. Please use a quality, high resolution film to ensure clarity. The outdoors is usually the best setting for a clear photo. Digital photographs are welcome. For best results, please send digital photographs as JPG files.
- 16. **Confirmation Packet**—A confirmation packet and the tournament brackets will be emailed and/or mailed approximately the week of December 27, 2021 to the head coach/director listed on the Official Registration Form.

- 1. **Eligibility**—The Cheer Competition is open to all boys and girls that fall in the two (2) age brackets below. Eligibility is determined by the grade of the contestants as of January 15, 2022. Proof of grade will be established prior to the competition.
- 2. **Age Brackets**—Two (2) brackets will compete in the 2022 SERC Martin Luther King, Jr. Cheer Competition: 8th Grade & Under and 9th Grade & Up. Each member must be competing in their appropriate grade bracket.
- 3. **Entries**—All contestants must register using the official 2022 SERC Martin Luther King, Jr. Basketball Tournament & Cheer Competition entry form. Completed entry forms should be submitted with tournament registration forms no later than 5:00 p.m. CST on Friday, November 19, 2021. Each registered team may submit only two (2) competing cheer/dance teams (one per age bracket).

4. **Regulations**

- All teams, gyms, coaches and directors must have an emergency response plan in the event of an injury.
- All height increasing apparatus used to propel an athlete is **not allowed**.
- No tumbling mats will be provided.
- Required spotters for all skills must be your own team's members, and be trained in proper spotting techniques.
- Routine performance may not exceed five minutes. Timing will begin with the first movement, voice, or note of music, whichever comes first. Timing will end with the last movement, last voice, or note of music, whichever comes last.
- 5. Athletes must have at least one foot, hand or body part (other than hair) on the performing surface when the routine begins.
- 6. The competitors who begin a routine must remain the same throughout the course of a routine. A performer is not permitted to be "replaced" by another performer during a routine.
- 7. An athlete must not have gum, candy, cough drops or other such edible or non-edible items, which may cause choking in his/her mouth during practice and/or performance.
- 8. All cheers and music must be positive in nature. No profane, explicit, or questionable language or music may be used in any cheer. Music selection must be submitted by January 3, 2022.
- 9. Any dance moves should be in good taste and never be suggestive in any way, shape, or form.
